

WHAT TO KNOW ABOUT KIDS AND BIKE SAFETY



BEING SAFE WHILE RIDING A BIKE ISN'T JUST A GOOD IDEA, IT'S ALSO THE LAW FOR ALL RIDERS UNDER 16 IN NORTH CAROLINA.

THERE ARE MANY RULES AND REGULATIONS DESIGNED TO KEEP RIDERS SAFE. IT IS IMPORTANT TO START WITH SAFETY FUNDAMENTALS FROM AN EARLY AGE.

ONE OF THE BEST WAYS TO PROTECT YOUNG RIDERS IS TO INSIST ON HELMET USE. IT'S THE LAW!

HERE'S WHAT TO LOOK FOR:



TRY IT ON!

MAKE SURE THE HELMET IS
THE PROPER SIZE. HELMETS
SHOULD FIT SNUGLY, WITHOUT
MOVING SIDE TO SIDE OR
SLIDING BACK AND FORTH
OVER THE FOREHEAD.



TWO FINGERS

THE HELMET SHOULD SIT LOW ON THE FOREHEAD, ONLY ONE OR TWO FINGER-WIDTHS ABOVE THE EYEBROWS.



FORM A "Y"

"Y" ON EACH SIDE AND MEET RIGHT BELOW THE EAR.

SIDE STRAPS SHOULD FORM A



FIT SNUGLY

THE CHIN STRAP SHOULD FIT SNUGLY, WITH ROOM FOR NO MORE THAN ONE FINGER BETWEEN THE STRAP AND THE CHIN.

A **HELMET'S** NOT THE ONLY THING NEEDED FOR SAFETY, THOUGH.

THERE ARE MANY OTHER ASPECTS OF **BIKE SAFETY** YOU'LL WANT THE WHOLE FAMILY TO BECOME FAMILIAR WITH BEFORE HEADING OUT ON THE ROAD.







BIKE FIT:

A HELMET ISN'T THE ONLY THING THAT REQUIRES A
PROPER FIT. THE BIKE FRAME, WHEELS AND SEAT HEIGHT
SHOULD ALL BE IN RELATION TO THE CHILD'S HEIGHT.
MAKE SURE TO HAVE YOUR CHILD TRY THE BIKE FOR SIZE
PRIOR TO PURCHASE. TALK TO AN EXPERT AT YOUR LOCAL
BIKE STORE TO MAKE SURE YOU GET THE RIGHT FIT!

ROAD RULES: GET YOUR CHILD FAMILIAR WITH THE SIGNS AND

SIGNALS THEY WILL SEE WHILE ON THE ROAD. FROM HAND SIGNALS FOR TURNING TO TRAFFIC LIGHTS AND ROAD SIGNS, THEY'LL NEED THIS INFORMATION TO STAY SAFE WHILE NAVIGATING THE STREETS.



SHARE THE ROAD

BE SEEN:

ALWAYS WEAR BRIGHT COLORS WHEN RIDING AND ADD REFLECTORS AND FRONT AND REAR LIGHTS TO YOUR CHILD'S BIKE. THIS WILL HELP THEM BE MORE VISIBLE TO DRIVERS, AND THE LIGHTS AND REFLECTORS ARE ACTUALLY REQUIRED BY LAW IN NC.
